Astute LXP Release Notes – October 2025 (V3.4.4)

Release Date: October 30th 2025

This month's release focuses on smoother administration and improved stability across Astute.

We've refined enrolment controls, added extra filtering options, strengthened data validation for user syncs, and enhanced performance across reporting.

You'll also notice quality-of-life updates to Certificates, Trigger Emails and Risk Assessments.

Enhancements

- **Enrolment Events** Once an event has started and learners are enrolled, the start date can no longer be changed.
- Enrolment Events When creating an enrolment event with re-enrolment enabled, you must now choose the re-enrolment method before saving the event (previously defaulted to "date enrolled").
- **Learners Page:** Added a new filter to view learners by HR Representative.
- **Course Uploads:** Astute now supports importing specialist multi-SCORM .zip files.
- **Previous LMS Records:** Filters now support selecting multiple options at once.
- User Sync's via API: If a user sync attempts to set a learner as their own manager or create a loop (e.g. a manager of a manager), Astute will reject the invalid manager email
- Release Notes Button: Now opens in a new tab.

Performance Improvements

• Filtering by username in LXP Reporting now returns results significantly faster for clients with a high volume of learners.

Bug Fixes

- **Learner Homepage:** Fixed an issue where some course titles were truncated on the homepage banner.
- **Learner Homepage:** Correct tile image now displays when a user self-enrols onto an event.
- **Enrolment Events:** Resolved an intermittent issue where enrolling a learner onto an event did not always enrol them on all activities.
- LXP Reporting: Fixed the uploader for Policy Supporting Files.
- **LXP Reporting:** "Uploaded Evidence" column now shows correctly in the Policy LXP Report Builder.
- **LXP Reporting:** The Standard Duration column in Report Builder now shows more accurate timings.
- **LXP Reporting:** Resolved an issue where only course enrolments were appearing in LXP Report Builder in some cases.
- **Email Management:** Certificates now correctly attach to Trigger Emails set to "When a course is passed."
- **Email Management:** Trigger Email options for "When a programme is enrolled on" and "When a programme is completed" now display again as expected.
- **Email Management:** Chaser emails for outstanding video enrolments now send as expected.
- **Email Management:** Fixed Chaser Email options in the "but not yet" section for videos.
- **Compliance Reporting:** Additional Fields dropdown in Compliance Reporting is now ordered correctly.
- **Risk Task List:** "Recorded On" now reflects the date a learner completed the assessment rather than the enrolment date.
- **Risk Assessment V2:** Resolved issue where re-entering after completion could reset status to incomplete.

- Risk Assessment V3: Mandatory Notes can no longer be skipped by clicking "Cancel."
- **Risk Assessment V3:** Suggested Action text now displays properly when clicking the action triangle.
- **Certificates:** Certificates downloaded using the "Download All" now populate the "LastPassed# merge field as expected.
